Agenda Item 5 – A: Latinos Unidos: Invited Partnership with Orange County United Way

The Orange County United Way (OCUW) has presented the Garden Grove Unified School District with \$25,000 to support the Latinos Unidos (LU) project for the 2015-16 school year. This is the third year of an invited partnership. Latinos Unidos is a district-wide organization whose purpose is to provide support systems to Latino students in order to achieve academic success. Active Latinos Unidos clubs exist at all district high schools.

Program goals will be accomplished through the following five key activities: 1) tutoring and academic support; 2) mentorship; 3) community service; 4) college preparation; and 5) social/cultural events. Funding will support all club activities and programs, including costs related to materials and supplies, printing, transportation, conference fees, and teacher hourly. Two major events sponsored by this funding are the Annual Latinos Unidos Conference for student leaders and the Latino Cultural Night organized for students, parents, and the community.

Destination Graduation is the Orange County United Way's education initiative designed to ensure all students transition to and graduate from high school, college and career ready. The Garden Grove Unified School District has participated in the Destination Graduation program since 2013. Through this partnership, the Orange County United Way will provide additional one-time grant funding in the amount of \$40,000 to focus on providing STEM (Science, Technology, Engineering, and Math) programming for students in grades seven and eight. Programs will run concurrently with other district summer programs, or as an afterschool program in fall 2016.

Effective October 12, 1994, the State of California approved the use of California Multiple Award Schedules (CMAS) by local governments (i.e. city, county, district, or other local governmental body empowered to expend public funds) for information technology products and services. Using a CMAS contract would be a cost-effective manner of procurement for information technology products and services.

Public Contract Code Sections 10298, 10299, and 12100 provide that the governing board of any school district, without advertising for bids, may authorize any public agency to purchase equipment and services for its use in the manner in which the public agency is authorized by law to make such purchases. The State of California authorized school districts to purchase product and services from the businesses listed below on the CMAS in accordance with the same specifications, terms, and conditions. The mandatory functions of the Bond Oversight Committee (BOC) set forth in Education Code are to: 1) actively review and report on the proper expenditures of taxpayers’ money for school construction; 2) advise the public as to whether the district is in compliance with Section 1(b)(3) of Article XIII of the California Constitution; and 3) provide oversight to ensure that bond revenues are expended for the purposes described, and that no funds are used for any teacher or administrative salaries or other school operating expenses.

Bond Oversight Committee members serve staggered two-year terms with some terms expiring May 10, 2016. The invitation to apply and application form to identify qualified replacement members was made available February 10, 2016, and was announced in several local media, including the district’s website. The deadline for receipt of applications was March 18, 2016. Three current members who met the application criteria reapplied. It is recommended that all three applicants be approved for reappointment to the BOC to serve a two-year term, May 2016 through May 2018.

Each year staff studies accident insurance plans and recommends a plan to be made available for purchase by district students. Based on a review of plans available, premium costs, and level of service, Myers-Stevens & Toohey & Company offers the best variety of coverage available. Myers-Stevens & Toohey & Company has provided accident insurance to district students since the 1980-81 school year. The company also offers tackle football, health, and dental plans at reasonable costs. Their record of service has been excellent and the rates remain competitive with no increase since 2013.

Premiums are experience-rated reflecting levels of utilization and costs of plan administration. The 2016-17 plans are underwritten by BCS Insurance Company. Insurance plans are available to all students, preschool through twelfth grade.
