The meeting was called to order by Chairperson West at 7:00 p.m. followed by the Pledge of Call to Order Allegiance.

Tina Gurney, GGEA president, addressed the Board to share information items. The GGEA has moved to a new office within the building where they have been housed. This week and next, GGEA is holding a phone banking to call and inform their members of the importance of the upcoming elections and Propositions 30 and 32. Tina also gave background information on both propositions.

Hearing no comments or corrections, Chairperson West declared the Minutes of the September 4, 2012, Regular Board Meeting approved as submitted.

Chairperson West called for a short recess at 7:15 p.m to "meet and greet" the new administrators. The meeting was called back to order at 7:28 p.m.

On motion of Trustee Bao Nguyen, seconded by Trustee Harden, and unanimously carried, the Board of Education extended approval to any district high school athletic team or individual athlete qualifying for a C.I.F. sanctioned post-season competition to participate in those events during the 2012-13 school year, even if such events require overnight stays. Trips for C.I.F. post-season competition which necessitate an overnight stay will still require prior approval of the Assistant Superintendent, Secondary Education.

On motion of Trustee Bao Nouven, seconded by Trustee Harden, and unanimously carried, the Board of Education approved participation by 62 Pacifica High School Marching Band members in Western Band Association Championships at Fresno on November 16-18, 2012.

On motion of Trustee Reed, seconded by Trustee Lan Nouven, and unanimously carried, the Board of Education adopted Resolution No. 14 which authorizes emergency roof repairs for Stanley Elementary School (rooms 41 through 44), Wakeham Elementary School (walkway cover), and Doig Intermediate School (buildings B & G).

Student Representative Juarez reported that the first BRC meeting of the school year will be Discussion - Board held on October 2, 2012, using a newly reformatted BRC agenda. He mentioned upcoming events for the high schools: CAHSEE testing, College Fairs and College Information Nights, and Red Ribbon Week. Trustee Reed thanked the new administrators who were introduced to the Board for coming to the meeting at this busy time of year. She was impressed by the community support shown to the Los Amigos baseball program after the theft of their equipment. She asked the superintendent to convey thanks on behalf of the Board to those who donated funds to replace the equipment. She said that she is pleased to see that Marilyn Tortolano has been appointed for another term to the Personnel Commission. Trustee Bao Nguyen echoed his appreciation for support shown by the Los Angeles Angels Foundation and others for the Los Amigos baseball program. He thanked Tina Gurney for the information she presented on the two propositions coming up in the November 6 elections. Chairperson West noted the need for a closed session to discuss potential litigation. The Information Item members of the Board agreed that a closed session would be held at 5:30 p.m., on October 2, 2012, prior to the start of the regular Board of Education meeting that evening.
