The meeting was called to order by the Secretary to the Board of Education at 7:00 p.m. Call to Order followed by the Pledge of Allegiance.

Student Representative to the Board, Frank Valenzuela, was absent from the meeting due to a Information Item school event.

The Secretary of the Board of Education called for nominations for the office of President of the Call for Nominations Board of Education.

On motion of Trustee Reed, seconded by Trustee Lan Nguyen, and unanimously carried, the Board of Education reelected Trustee West to serve as President of the Board of Education, (111) effective this date.

The Superintendent thanked Trustee West and presented him with a commemorative gavel for Presentation of Gavel his service as Board President during 2013.

Chairperson West called for nominations for the office of Vice President/Clerk of the Board of Education.
