Chairperson Lan Nguyen opened closed session at 5:00 p.m. to receive comments from the public limited to the item described herein. There were three comments from the public on the Superintendent's evaluation: Nicholas Dibs (Garden Grove resident) who thanked the Superintendent for taking time to meet with him and voiced his respect and admiration for her; Tan Luong (district parent) who also thanked the Superintendent for taking time to meet with him and for being more than just the figurehead of the district; and Esther Morales (district parent) who commented that she gives her support and gratitude to the Superintendent and the district is fortunate to have her as a role model and leader. Information Item

Nicholas Dibs (Garden Grove resident) addressed the Board to request that district Board Policies be added to district website along with LCAP proposals. He would also like to see the district add auto shop classes to the high schools that do not have them, along with expansion of CTE classes.

Public Comments

Demian Garcia-Monroy (district parent) addressed the Board to offer his congratulations on their promotions to Valerie Shedd, Assistant Superintendent of Special Education/Student Services, and Matthew Lambert, Director of Special Education. He also said that parent education is important in order to help empower them and to help reduce the legal costs of litigation.

Patricia Guzman, Hermila Martinez, Angie Nogales, Flora Tellez, and Lourdes Xool (residents of Trustee Area 3) addressed the Board in regards to LCAP and the importance of district support for student mental health. The speakers noted that there is a need for more school psychologists, counselors at the intermediate school level, student support groups where students can share their problems, student and parent education classes, and support from the local police departments in order to address the needs of student mental health.
