He also reported on site visits to La Quinta and Rancho. In regards to an article he read in the OC Register, he asked staff if fourth grade students still work on the California Mission projects. Sara Wescott, Assistant Superintendent of Elementary Education, replied that there are some teachers who still use this project for homework or extra credit. She also said that in the near future, new social studies materials will be reviewed for different perspectives referred to in the article. He spoke about a growing movement to replace Columbus Day to celebrate Indigenous Day and requested that students be taught history from all accounts.

Trustee Rocco Reported on her Back-to-School Night attendance at Bryant and Enders. She attended the "Bite of Reality" event at Pacifica which simulates real-world financial experiences. She also commented on the Joyful Feast event she attended, held by the Joyful Child Foundation, which empowers elementary children with safety education.

Trustee Harden had no comments.

Chairperson Lan Nguyen thanked staff for the impressive launch event for the Vietnamese Dual Language Immersion at Murdy. He also commented on the Joyful Child Foundation event he attended and thanked Arthur Cummins, Director of Student Services, for his service as chairman on the Joyful Child Foundation Board of Directors.
